I understand that the information furnished above is for the purpose of obtaining credit from ABC Cutting Contractors of Atlanta, Inc., and that I am authorized, in my capacity to bind my firm accordingly, and that all accounts or monies due you shall be due within 15 days from the date of the invoice; that all past due accounts shall draw an interest at the rate of 1.5% per month. In the event that my account has to be referred out for collection, I agree to pay 33% of the principal balance for the purpose of collection and legal fees in addition to the invoice balance and interest charges. I understand our terms are **not** pay when paid, unless we have a written Agreement signed by both parties spelling out the payment terms according to a specific project. I understand that should my account become past due, my right to purchase on credit may be suspended until past due balances are paid.

In order to induce ABC Cutting Contractors of Atlanta, Inc., a Georgia Corporation having its principal office in College Park, Clayton County, Georgia ("ABC Contractors") to extend credit to _____ ("Debtor") from time to time in its sole discretion, the undersigned guarantor ("Guarantor") hereby absolutely and unconditionally guarantees to ABC Contractors and its successors and assigns the due and punctual payment, and the due and punctual performance, of all present and future obligations and liabilities of Debtor to ABC Contractors, whether direct, indirect, joint, several, absolute, contingent, secured, unsecured, matured or otherwise, assigned or otherwise (collectively the "Guaranteed Obligations").

- Default:** (a) This agreement is binding upon its execution by ABC Contractors and will continue in force until terminated in writing by notice given to the other party or parties not less than 30 days prior to the designated termination date.
- b) It is agreed that default is defined and determined at the discretion of ABC Contractors and upon default, the Agreement will be terminated without notice.
- c) Upon termination, all amounts owed to ABC Contractors will be due and payable without demand or notices of any kind (all of which the Applicant expressly waives). ABC Contractors will not be liable for any direct or consequential damages that may be suffered as a result of the termination.
- d) If this Agreement is terminated, ABC Contractors will be entitled to recover, and must be paid upon demand, a minimum of 33% of the principal balance in addition to the actual principal amount for the purposes of collection fees, legal fees, court costs, and internal costs associated with recovery of the money that the Applicant owes.
- e) The governing law for this agreement shall be the County of Clayton in the state of Georgia. The Applicant expressly waives all jurisdictional rights.

It is agreed and understood by and between ABC Contractors and the Debtor and Guarantee hereto that a facsimile copy of this document dated and signed by the authorized agent of the Debtor shall be considered an original document and enforceable as such.
